□ ANACOM STATISTICS

At the end of 2004 the Portugal Telecom group held a 93 percent share of the market for installed fixed telephone service accesses, indicates the most recent statistical information compiled and released by the Autoridade Nacional de Comunicações (ANACOM).

During the same period, 28 percent of all Portuguese households subscribed to cable television distribution service. Cabled households stood at 72 percent of total households.

Regarding data transmission service (internet access), at the end of last year there were about 6.7 million internet access service customers in Portugal, most

□ <u>SUBSCRIBER LINE RESALE OFFER (SLRO)</u>

The Autoridade Nacional de Comunicações (ANACOM) approved by determination of 29 April the decision on the reference proposal for the subscriber line resale offer (SLRO).

The minimum information to include in this reference proposal was namely included, along with specifications applicable to entities that benefit from the offer, including the access and services covered, prices, implementation process, invoicing and coverage of included services, parameters and service quality levels and penalties for non-compliance, relations with end users, definition of responsibilities, and dispute settlement and relations between the SLRO and

of whom (87 percent) used dial-up. The remaining 858 000 customers have broadband accesses, by ADSL and cable.

With respect to postal services operated in competition, postal traffic was seen to increase by about 11 percent compared to the previous quarter. More than 72 million objects were distributed over the course of 2004.

□ RADIOMÓVEL FREQUENCIES

On 15 April the Autoridade Nacional de Comunicações (ANACOM) decided to grant Radiomóvel a period of one month to regularise or otherwise express itself regarding non-compliance with the obligation for analog and digital systems to migrate to CDMA technology, as per terms of the licence, and for efficient use of the frequencies allocated for the provision of trunking mobile service (TMS) according to the CDMA technological system.

ANACOM may reassess Radiomóvel's right to use the frequencies assigned it in this technology if it discovers that same are not being used efficiently.



- Council of Ministers Resolution no. 87/2005 (I Series-B of the Diário da República of 29 April) Creates the programme INOV-JOVEM Young Personnel for Innovation in Small and Medium-Sized Businesses.
- Joint Order no. 309-A/2005 (II Series of the D.R. of 19 April) Approves the specific regulation of measure no. 5.1, "Quality and Efficiency in Public Services", under the Information Society Operational Programme.
- Decree-Law no. 79/2005 (I Series-A of the D.R. of 15 April) Approves the Organic Law of the 17th Constitutional Government.
- Council of Ministers Resolution no. 82/2005 (I Series-B of the D.R. of 15 April) Approves the regime governing the Council of Ministers of the 17th Constitutional Government.

The 21 April Council of Ministers (CM) approved the Resolution setting out the goals, powers and organic structure of the Technological Plan Co-ordination Unit (UCPT).

The 14 April CM approved the proposed Law that establishes rules for the appointments of high officials in Public Administration.

EUROPEAN UNION

PORTUGAL TARGETED BY INFRINGEMENT PROCEEDINGS

Portugal is one of the ten countries (along with Finland, Germany, the Netherlands, Austria, Italy, Slovakia, Latvia, Poland and Malta) targeted by infringement proceedings filed by the European Commission and based on the failure to comply with community rules on electronic communications. The Commission indicates the existence of defects in national legislation and incorrect application of the sector regulatory package.
