QUALITY REGULATION AND NFAP

The Autoridade Nacional de Comunicações (ANACOM) approved by determination adopted on 4 May the quality regulation applicable to the service of access to the public telephone network at a fixed location and to telephone service publicly available at a fixed location.

This regulation, prepared under articles 40 and 125 of the Electronic Communications Law (Law no. 5/2004 of 10 February), covers areas such as service quality parameters, the obligations of providing enterprises, information systems and procedures used to measure those parameters, unexpected and force majeure situations, the quarterly delivery of information to ANACOM and the availability of information for users.

The regulation, to soon be published in the 2nd Series of the *Diário da República*, should see its scope expanded in the future, with a view to setting the quality levels the providers of other electronic communication services should comply with.

The same determination also approved the final report of the general consultation procedure carried out in late 2004.

Also on 4 May, ANACOM approved the National Frequency Allocation Plan (NFAP), thus complying with the stipulations of article 16 of the Electronic Communications Law and the process of public hearing to which the document was subject in December of last year.

The NFAP comprises the frequency allocation table and indication of the frequencies allocated and reserved and to be made available in 2005, in the scope of electronic communications networks and services, whether publicly available or not.

DECISION CONCERNING MARKET 10

By determination adopted on 25 May, the *Autoridade Nacional de Comunicações* (ANACOM) concluded that the transit market in the fixed location public telephone network (market 10 of Recommendation 2003/311/EC of 11 February) is a market with residual and competitive importance, and thus decided not to include it as a relevant market for effects of ex ante regulation.

This market, whose geographic extent is the national territory, includes the transit services that an operator provides when conveying calls originating and terminating in a network other than its own.

The transit market's relevance in the context of the narrowband interconnection markets is currently merely residual, representing just 1 percent of total routed interconnection traffic, considering the narrowband markets. Its importance is

not expected to increase substantially.

As companies with significant market power (SMP) were not identified, no ex ante regulatory obligations whatsoever will be upheld or imposed. Thus, and given the provisions of section 3 of article 59 of Law no. 5/2004 of 10 February, the obligations imposed on PTC in the fixed location public telephone network transit market, as the notified SMP holding operator in the national interconnection market under the previous regulatory framework, will be withdrawn within 50 working days.

CONSULTATION ON COMMUNICATION SERVICES CONTRACTS

The guidelines on minimum content to include in the contracts for the provision of electronic communication services are undergoing a 30-day public consultation, as per the procedure envisaged in the Electronic Communications Law (Law no. 5/2004 of 10 February).

With the aim of ensuring protection of consumer rights and a transparent relationship between operators and customers, ANACOM proposes that various items should be included in such contracts, namely indication of the supplied services, quality levels, time period for initial connection, maintenance, prices, availability of information and anticipated situations of indemnity or reimbursement.

NEW PT COMUNICAÇÕES PRICE TABLES

By determination of 17 May, the *Autoridade Nacional de Comunicações* (ANACOM) decided not to oppose the entrance into force on 1 July of the proposed retail price table for telephone service provided at a fixed location, presented by *PTComunicações* (PTC) on 5 May, without jeopardising compliance with the obligation to divulge and publish, as per the terms of section 3 of article 48 of Law no. 5/2004 of 10 February.

This price table modification is substantiated by an annual average variation of the price basket (installation, monthly fee, and local, regional and national calls) of -0.75 percent, with spot variation of -2.75 percent.
