☐ MARKET 12 - WHOLESALE BROADBAND ACCESS

In the wake of the public consultation launched on 24 November 2004, which included the corresponding draft decision from the *Autoridade Nacional de Comunicações* (ANACOM) on the wholesale broadband access market (market 12 of the European Commission Recommendation), ANACOM approved on 24 June the determination concerning definition of the product markets and geographic markets, assessment of significant market power (SMP) and the imposition, maintenance, amendment or withdrawal of regulatory obligations in the wholesale broadband access market.

This market, identified as being relevant for purposes of *ex ante* regulation, and in which the PT group holds SMP, is thus subject to a set of objections, specifi-

cally obligations to access and use specific network resources, transparent publication of information, in particular the broadband access reference offer ("PT ADSL Network"), non-discrimination in the access and interconnection offer, price orientation to costs and price control, maintenance of the costing system and accounts separation and availability of the accounting records. ANACOM has notified the Commission of the adopted measures, as per article 57 of Law no. 5/2004 of 10 February and Directive 2002/21/EC.

□ PT ADSL NETWORK

A determination dated 24 June approved the decision on changes to make in the "PT ADSL Network" wholesale offer, as well as the report from the prior hearing of interested parties on the corresponding draft decision approved last 9 May. The determination also approved a draft decision on changes to make in the same offer. Interested parties were given 10 days to pronounce on the probable

outcome of this decision, as per articles 100 and 101 of the Code of Administrative Procedure. The modifications now subject to prior hearing mainly concern the process of customer migration between service providers.

□ RETENTION OF PTC IN FIXED MOBILE TRAFFIC

The *Autoridade Nacional de Comunicações* (ANACOM) approved on 24 June the draft decision on the retention of *PT Comunicações* (PTC) in fixed-mobile traffic. PTC should gradually reduce the value of the retention offered in fixed-mobile traffic as a way for same to approach costs and current European practices. Interested parties were notified of this determination and given 20 working days to submit comments in writing, as per articles 100 and 101 of the Code of

Administrative Procedure.

The aim is to achieve a broad overview of this subject, including the case of Spain, the only European Union country with experience in the offer of capacity-based interconnection for voice and internet.

RENEWAL OF THE FREQUENCIES OF VODAFONE AND TMN

In a determination dated 8 June, the *Autoridade Nacional de Comunicações* (ANACOM) decided to renew the GSM and DCS 1800 frequency usage rights allocated to the mobile network operators Vodafone and TMN. The respective consultation will be carried out in July to assess the pertinent aspects to bear in mind when those operators' licences are renewed, namely in terms of effective coverage and quality of service. The Vodafone and TMN licences were allocated for a 15-year period, respectively expiring in 2006 and 2007. The Optimus licence only expires in 2012.

ANACOM ADVISORY COUNCIL

The ANACOM Advisory Council met on 21 June, with the agenda focusing on the activity plans and budgets for 2005-2007 and 2006-2008, the 2004 Regulation Report, the universal service price table and the establishment of a special commission for telecommunication infrastructures in buildings. This is the second time that this Council, chaired by Álvaro Dâmaso, has met; the first was in December 2004. Two opinions were approved at this session, the first on the ANACOM plan and budget for 2005-2007, and the second on the retail price table for telephone service provided at a fixed location (of *PT Comunicações*), as well as the Advisory Council's internal rules. The next meeting is scheduled for 12 July.

SONAECOM COMPLAINTS AGAINST PT

Sonaecom announced at an 8 June press conference that it had filed two complaints with the European Commission, accusing the historic operator *Portugal Telecom* of abusing its dominant position in the national broadband market and the Portuguese State of illegal aid to the PT group.

Sonaecom contests the lack of a public tender during the sale of the basic telecommunications network to Portugal Telecom and advocates the separation of the copper-wire and cable television networks currently held by the incumbent.

The 30 June Council of Ministers (CM) approved the resolution appointing Carlos Zorrinho as National Co-ordinator for the Lisbon Strategy, reporting directly to the Prime Minister

The 15 June CM approved a Major Planning Options proposal for the period 2005-2009, along with the main action lines, policy measures and investment priorities that will aid the implementation of same.

The 2 June CM adopted a resolution approving an integrated set of measures on management of the civil service.

The 19 May CM adopted a resolution approving for ratification the Additional Protocol to the Convention for the Protection of Individuals with Regard to Automatic Processing of Personal Data regarding supervisory authorities and trans-border data flows, of the Council of Europe, which was opened for signing on 8 November 2001 in Strasbourg.

The 12 May CM approved a proposed law to establish a Regulatory Entity for the Media (ERC), replacing the High Authority for the Media (AACS), and also a proposed law to establish respective Ombudsmen for the audiences of public radio and television services.

□ **EUROPEAN MARKET INSPECTION CAMPAIGN**

The *Autoridade Nacional de Comunicações* (ANACOM) participated from October 2004 to May 2005 in a European inspection campaign for the electromagnetic compatibility market, together with 15 other European countries.

The campaign consisted of inspecting the technical conformity of various kinds of energy-saving bulbs by carrying out trials in the ANACOM laboratories. The national results indicate a 23 percent rate of technical non-conformity for the 13 equipment items examined, for which five examples of each were tested.

The aim of this European campaign was for the member States to exchange information, to enable the new States to take part in an inspection campaign and to increase consumer and industry awareness of the relative importance of electromagnetic compatibility.

At European level, a 29 percent rate of technical non-conformity was verified, i.e., 50 of the 174 kinds of equipment tested had values above the applicable standards.

IPV6 WORKSHOP

A workshop sponsored by the ITU Standardisation Sector (ITU-T) was held on 22-23 June and concerned IPv6, the protocol that will gradualy replace the current IPv4 - the basis for communication across the entire internet.

The migration has been very slow, mainly due to successive improvements to the IPv4 protocol (IPSec and NAT, among others), which has allowed its use to

be prolonged.
