

EMERG # Wrap up by April 2021

Dear colleagues,

The first 2021 quarter flew by so rapidly and April was key to EMERG. We held our CN and Plenary meetings and we also took some steps towards the implementation of the 2021-2022 Work Programme.

Also, during this 1st quarter, the European Commission presented the <u>Europe's Digital</u> <u>Decade 2030</u>, which sets EU common targets for



a successful digitalization as well as a monitoring system to track the progress. This new strategy aims at having all European households covered with gigabit connectivity and a target that at least 75% of European businesses have taken up digital solutions like cloud computing or Artificial Intelligence. Within this context, the EC also identified the role for building international partnerships, which will be one of the key aspects of the Digital Decade. As the EC vice-President Vestager said "In an open digital economy, partnerships help us fast-forward the development of European technologies which can hopefully become global solutions. (...). We will work to address the large connectivity gaps in the developing world while promoting our human-centric model, and we will explore setting up a new Digital Connectivity Fund to that end".
