RESUMPTION OF DTT NETWORK MIGRATION

In accordance with the proposal for resumption of the digital terrestrial television (DTT) migration process submitted by MEO Serviços de Comunicações e Multimédia, which the government agreed to, the Autoridade Nacional de Comunicações (ANACOM) approved on 18 June the new calendar for that process. As one of the companies involved in the services of retuning transmitters

in the wake of the COVID-19 pandemic was no longer available, ANACOM approved a further calendar change on 16 July. The process thus resumed in the district of Portalegre with retuning of the Alter do Chão transmitter on 12 August. When the TV screen goes black it will only be necessary to tune the TV or the DTT decoder. (+)

UPDATE OF THE 5G CALENDAR

The public consultation on the draft regulation for the auction to allocate frequency usage rights for 5G and other relevant bands (700 MHz, 900 MHz, 1800 MHz, 2.1 GHz, 2.6 GHz and

3.5 GHz) ended on 3 July. ANACOM plans for the auction to begin in October and that the frequency usage rights will be allocated in 2021. (+)

GUIDE ON MOBILE NETWORKS AND HEALTH

ANACOM has published a guide on "Mobile Networks and Health - facts, data and challenges". The aim is to provide

clear explanations regarding 5G, with transparent and neutral information based on scientific knowledge. (+)

5G TECHNICAL TRIALS

ANACOM has been authorising the temporary use of radio spectrum to conduct technical trials and scientific studies using

various technologies, specifically those that will contribute to the launch of 5G in Portugal. (+)

MULTIANNUAL ACTIVITIES PLAN - 2021-2023

ANACOM released on 22 June the "Report on Regulation, Supervision and Other Activities" in 2019. (+)

TRENDS IN TELECOMMUNICATIONS PRICES

ANACOM published on 22 July the report on "Trends in Telecommunications Prices", with figures for the month of June. (+)

TELECOMMUNICATIONS PRICES IN PORTUGAL

ANACOM released on 4 June an updated version of the analysis of telecommunications prices in Portugal. (+)

COVID-19

• Guide to clear up doubts

ANACOM has updated the practical guide published last May, which focuses on the pandemic's impact in the Portuguese communications sector. The guide is meant to respond to consumers' main questions regarding this situation. (+)

• Complaints about communication services

ANACOM was notified of nearly 13,300 complaints about communication services in June, 90 percent more than in

the same month of the previous year, when just over 7,000 complaints were recorded. (+)

• Communications traffic

From 20 to 26 July and compared to the previous week, data traffic fell by 7 percent, though it was 40 percent higher than the figure recorded the week before the pandemic was declared. (+)

MEETINGS WITH LOCAL AUTHORITIES

ANACOM met on 1 and 27 July with the local authorities of Porto de Mós (+) and Ourém, (+) respectively, to present results of the study assessing the performance of mobile services and GSM, UMTS and LTE coverage in those counties and to discuss problems associated to mobile, voice and internet communications, among others.

ANACOM PUBLIC PARTICIPATION

The chair of the board of directors, João Cadete de Matos, participated on 23 July as a speaker at the World Summit on the Information Society Forum (WSIS Forum), in the high-level session focusing on the topic of 'inclusiveness, access to information and knowledge for all'. (+)

Press officer Ilda Matos took part in the Economy 24 section of the Morning Daily programme of TVI and TVI24 on 22 July, discussing complaints regarding communication services and exceptional legal measures to respond to the COVID-19 pandemic, in force until 30 September. (+)

The head of the ANACOM office in Madeira, José Nelson Melim, participated in the following:

MOBILE SERVICE QUALITY IN LISBON

The Autoridade Nacional de Comunicações (ANACOM) conducted a study assessing the performance of mobile voice and data services and GSM (2G), UMTS (3G) and LTE (4G) coverage provided by MEO Serviços de Comunicações e Multimédia, NOS Comunicações and Vodafone Portugal Comunicações Pessoais in the Lisbon metropolitan area, which encompasses 18 municipalities and about 3,000 km2 (3 percent of the country's surface area). (+)

NET.MEDE - TESTS CONDUCTED IN THE 1ST QUARTER

Nearly 286,000 internet speed tests were conducted in the first quarter using the NET.mede tool, mostly in fixed accesses. This number represents an increase of 58 percent and is partly

due to the numerous tests conducted since the start of the pandemic situation decreed by the World Health Organisation (WHO) on 11 March. (+)

REGULATION COSTS - 2020

By decision dated 16 July, ANACOM approved the calculated amount of regulation costs for settling year 2020 fees associated to the activity of provider of electronic communication networks and services (33,819,903 euros) and to the activity of provider of postal services (2,531,166 euros),

as well as the conducting of audits of the relevant income and business volume of suppliers of publicly accessible electronic communication networks and services and of postal service providers. (+)

TRANSFER OF FREQUENCY USAGE RIGHT

By decision dated 26 June, ANACOM decided not to oppose the transfer of the frequency usage right in the 87.5-108 MHz band allocated to M90 Radiodifusão for the provision of local radio programme service in the county of Vila do Conde to the ownership of Rádio Sem Fronteiras Soc. de Radiodifusão. (+)

FOURTH WIFI4EU CALL

The results of the 4th WiFi4EU call were announced in July. A total of 12 Portuguese municipalities were awarded vouchers,

raising to 277 the number of national municipal councils provided with funds to install WiFi in public spaces. (+)

COMMUNICATIONS AROUND THE WORLD

EUROPEAN UNION

EUROPEAN UNION PRESIDENCY

Germany assumes the rotating presidency of the Council of the European Union (EU) from 1 July to 31 December. The presidential trio is also formed by Portugal (first half of 2021) and Slovenia (second half of 2021). (+)

IMPLEMENTING REGULATION - 5G

The European Commission (EC) adopted on 30 June an implementing regulation concerning the installation of wireless access points covering small cells, in the scope of implementation of 5G networks. The aim is increase data coverage and capacity in the EU. (+)

POSTAL SERVICE DIRECTIVE - CONSULTATION

The EC public consultation on the Postal Service Directive is under way until 9 November. The aim is to evaluate its impact and to understand postal sector needs, taking into consideration the growing e-commerce economy. (+)

NIS DIRECTIVE - CONSULTATION

The revision of the Network and Information Security (NIS) Directive, which took force in 2016, is under public consultation until 2 October. (+)

ROAMING REGULATION - CONSULTATION

The EC public consultation on the revision and extension of the Roaming Regulation (Regulation (EU) 2017/920 of 17 May) is under way until 11 September. (+)

CROSS-BORDER PARCEL DELIVERY - CONSULTATION

Also under way, until 30 September, is the public consultation on cross-border parcel delivery services. The aim is to gather

contributions concerning the application of Regulation (EU) 2018/644 of the European Parliament and of the Council of 18 April. (+)

APPLICATION OF THE GDPR

The EC published on 24 June the report evaluating two years of application of the General Data Protection Regulation (GDPR), which indicates fulfilment of most of the objectives and especially the creation of a new European system for governance and application of the data protection rules. (+)

INTEROPERABILITY BETWEEN TRACKING APPLICATIONS

The member-states, with EC support, reached agreement on a set of technical specifications meant to ensure secure data interchange between national coronavirus infection tracking applications, based on a decentralised framework. (+)

MEETING OF TELECOM MINISTERS

An informal videoconference of EU ministers responsible for telecommunications took place on 5 June. The main aim was to identify priorities for the digital sector in the wake of the COVID-19 outbreak. (+)

SPACE ACTIVITIES - COUNCIL CONCLUSIONS

The Council of the EU adopted on 4 June the conclusions on the role of space for a sustainable Europe, acknowledging the important role played by space activities for development of the skills, technologies and services needed to build a society able to face global challenges in a changing world, including climate change, deteriorating ecosystems, health crises, food security and migration. (+)

BEREC

43RD PLENARY MEETING

The 43rd BEREC plenary meeting was held by videoconference on 11 and 12 June, along with the meeting of the BEREC Management Committee. A highlight was the adoption of

guidelines for assessing the efficiency of systems to advise the population transmitted by different means, the aim being to help member-states, specifically with a methodology for carrying out that evaluation. (+)

OECD RELEASES BROADBAND STATISTICS

The Organisation for Economic Cooperation and Development (OECD) recently released statistical data on broadband referring to 2019. Portugal presents a fixed broadband penetration rate of 38.6 percent, with domestic fibre optic penetration the 14th highest among the OECD countries. The number of mobile

broadband subscribers maintained growth of 5 percent, despite the penetration rate being quite high, with 21 of the 37 countries counting more than 100 subscribers per 100 inhabitants. Standing out are Japan, Estonia and Finland, respectively with 179 percent, 158 percent and 155 percent. (+)

ENVIRONMENTAL AND SEISMIC DETECTION BY SUBMARINE CABLE

The international submarine communications cable linking Portugal and Brazil, due to begin operating in the second quarter of 2021, will be capable of seismic detection in the section between Funchal and Sines - the world's first

international system to be endowed with that function. The collected data will be delivered to the national academy and to public institutions and agencies that study seismic activity. (+)

COVID-19 - POSTAL SERVICE MEASURES

The ERGP has released updated information about measures taken in the postal service area as a consequence of the crisis situation caused by the COVID-19 pandemic. (+)

PUBLIC CONSULTATION

The public consultation on the following runs until 27 September:

- ERGP Work Programme 2021 the aim being to contribute to the future Postal Services Directive of the European Commission.
- Report on Postal Definitions explores different parameters

that can be used to identify services and players in the postal sector in a future regulatory framework.

18TH PLENARY MEETING

The 18th plenary meeting of the ERGP took place on 30 June, chaired by Spyros Pantelis of the Hellenic Telecommunications and Post Commission (Greece) and vice-chaired by João Cadete de Matos of ANACOM. (+)

NEWS FROM OTHER COUNTRIES

GERMANY - Bundesnetzagentur (BNetzA)

• The conclusions from the public consultation on the application of blockchain technology in the communication (electronic and postal), energy and railway sectors were published on 30 June. Regarding electronic communications, they show that this technology is being tested to develop secure digital identities, to improve payment methods and financial processes between companies, e.g. for roaming service, and to permit transparent and efficient transactions in the internet of things. (+)

BELGIUM - Belgian Institute for Postal Services and Telecommunications (BIPT)

- The annual statistical report on the electronic communications sector for year 2019 was published on 8 July. It highlights a 33 percent year-on-year increase in fixed broadband internet use and an average monthly use of 150 gigabits per fixed broadband line. Also noteworthy is the 22.5 percent increase in the quadruple-play offering. (+)
- Decisions have been published, after public consultation, on temporary user rights in the 3600-3800 MHz frequency band for five operators: Cegeka, Entropia, Orange, Proximus and Telenet. These usage rights allow them to undertake the first developments for 5G. (+)

BRAZIL - Agência Nacional de Telecomunicações (ANATEL)

• A new webpage was launched in the ANATEL portal on 22 June. It concerns regulatory simplification and provides information about various actions in that area in recent years. (+)

CANADA - Canadian Radio-television and Telecommunications Commission (CRTC)

• The deadline for submitting bids in the scope of the auction of frequencies from 3450 to 3650 MHz for 5G technology has been postponed until 6 October. (+)

SPAIN - Comisión Nacional de los Mercados y la Competencia (CNMC)

• A statistical report on e-commerce in the fourth quarter of 2019 has been published. Highlights include the 23.5 percent increase in invoicing, which contributed to an annual total of 13.365 billion euros, travel agencies and tour operators as activity sectors with more revenue (12.5 percent of total invoicing), and the higher number of transactions, with 242 million more recorded (up 17.9 percent). (+)

FINLAND - Finnish Transport and Communications Agency (Traficom)

• The first licence in the 2300-2320 MHz frequency band for local mobile networks has been granted, addressed to a limited group of users, based on mobile communications technology and

for local implementation, such as, for example, to meet operating needs of factories, ports, airports, power stations and mines. (+)

- Results of a consumer survey conducted from April to June have been released, concerning internet service use in the second half of 2019. The figures show moderate expansion of high-speed mobile broadband service coverage. The category of domiciles with connections of up to 100 Mbps increased by 2 percent (reaching 93 percent). (+)
- The results have been released of the auction concerning the 26 GHz spectrum band for 5G implementation, starting on 1 July. The licences are valid until 31 December 2033. (+)

FRANCE - Autorité de Régulation des Communications Électroniques et des Postes (ARCEP)

A public consultation has been announced, under way until 14 September, concerning draft decisions on asymmetric obligations in the context of fixed broadband and super-fast fixed broadband market analyses, and on changes to the fibre optic regulatory framework. (+)

FRANCE - Agence Nationale des Fréquences (ANFR)

• The authorisation for 52,895 sites to operate using 4G technology was announced on 1 July. According to the information provided, five frequency bands in France currently supply 4G services, distributed as follows: 26,092 sites in the 700 MHz band; 43,732 sites in the 800 MHz band; 44,252 sites in the 1800 MHz band; 21,798 sites in the 2.1 GHz band; and 34,468 sites in the 2.6 GHz band. (+)

The NETHERLANDS - Authority for Consumers and Markets (ACM)

• The "Postal and Parcel Markets Scan 2019" was published on 2 July. It indicates an increase in the volume of parcels and at the same time a decline in the volume of individual and commercial mail, as has been the case in recent years. (+)

IRELAND - Commission for Communications Regulation (ComReg)

• Data on the quality performance of the universal service of access at a fixed location supplied by the designated operator (Eircom Limited) during the fourth quarter of 2019 and during the 2019-2020 period have been published. (+)

MOZAMBIQUE - Instituto Nacional das Comunicações de Moçambique (INCM)

• A new entity has been created by the INCM, the Telecommunications Traffic Control Unit (UCTT), whose mission is to oversee traffic control, management of SIM cards' registration and protection and security of telecommunication networks. (+)

HIGH-SPEED NETWORKS (1ST QUARTER)

High-speed network services at a fixed location reached 2.9 million home customers, up 9.8 percent over the same period

last year, when growth of 12.6 percent was posted. (+)

INTERNATIONAL PARCELS (2019)

The number of parcels routed in the postal networks of the main providers of parcel service in Portugal increased by 14.6

percent, with business volume up 9.1 percent. (+)

QUALITY OF UNIVERSAL POSTAL SERVICE

The Autoridade Nacional de Comunicações (ANACOM) approved on 16 July the criterion to adopt to assess fulfilment of the performance goals associated to universal postal service quality indicators, which are tabulated by means of samplings. (+)

CTT COST-OF-CAPITAL RATE - 2020

ANACOM approved on 4 June the decision on the cost-of-capital rate of CTT Correios de Portugal (Portuguese postal service)

applicable to financial year 2020 (9.7150 percent). (+)

INTERNATIONAL MAIL PRICES

By decision dated 23 July ANACOM considered that the price proposal for international mail services in the scope of universal postal service submitted by CTT does not comply with the pricesetting criteria for the postal services comprising universal service applicable to the year 2020. (+)

CROSS-BORDER PARCEL TARIFFS

ANACOM approved by decision dated 26 June the evaluation of the single-piece cross-border tariffs practiced in 2020 by CTT

as the provider of universal postal service. (+)
