## ALENQUER, CACÉM AND NAZARÉ CHOSEN FOR DTT START

By determination dated 22 December 2010 and in compliance with the switch-off plan, the *Autoridade Nacional de Comunicações* (ANACOM) decided that Alenquer, Cacém and Nazaré will be the first areas to end analogue terrestrial television broadcasts, respectively on 12 May, 16 June and 13 October,

and then receive the new digital terrestrial television (DTT). Local institutions and other relevant local bodies will take part in preparing the operation. The population will be informed in due time about the respective implications; an informative campaign about the end of analogue television is also planned. (+)

## ELECTRONIC COMMUNICATIONS IN THE 790-862 MHz SUB-BAND

ANACOM decided last 16 December 2010 to designate and make available the 790-862 MHz sub-band for the provision of electronic communication services, in accordance with Decision 2010/267/EU, amending the National Frequency Allocation

Plan (NFAP) to comply. However, this sub-band's availability before 2015 depends on determination of the technical and geographic conditions to ensure compatibility, particularly with respect to usage in Spain and Morocco. (+)

## POSTAL SERVICES IN COMPETITION - NEW SYSTEM

The Ministry of Public Works, Transport and Communications (MOPTC), through the office of the Assistant State Secretary for Public Works and Communications (SEAOPC), placed in public consultation until 10 January the draft law meant to establish the new legal system governing the provision of postal

services in full competition. This will assure transposition in a single instrument of Directive 2008/6/EC of the European Parliament and of the Council of 20 February 2008 and implies modification of the sector's entire regulatory framework in Portugal. (+)

## MODIFICATION OF MUX A DTT FREQUENCIES - CONSULTATION

By determination dated 22 December 2010, ANACOM approved the draft decision concerning the modification of some operating channels of Multiplexer A (Mux A) for digital terrestrial television (DTT) service assigned to PT Comunicações (PTC). At stake is the substitution of radio channels 61 (790-798 MHz), 64 (814-822 MHz) and 67 (838-846 MHz) assigned to

PTC by channel 60 (782-790 MHz) for mainland territory, channel 54 (734-742 MHz) for the Madeira Autonomous Region and channels 48 (686-694 MHz), 49 (694-702 MHz) and 55 (742-750 MHz) for the Azores Autonomous Region. ### **WORKSHOP ON 'THE R&TTE SYSTEM IN PORTUGAL'**

#### **- PRESENTATIONS**

### **FIXED TELEPHONE**

#### **- 3<sup>RD</sup> QUARTER 2010 STATISTICS**

Fixed telephone service statistics for the third quarter of 2010 were recently released and indicate the existence of about 4.4 million main telephone accesses installed at customer request, up 0.9 percent over the previous quarter and 5 percent year-on-year. The penetration rate stood at 41.1 accesses per 100 inhabitants. The drop in analogue accesses and the fewer basic and fractioned ISDN accesses were compensated by the growth of accesses supported by other technologies, especially VoIP/VoB. (+)

### **MFRW - UPDATE**

Updated information on the Municipal Fee for Rights of Way (MFRW) has been released.

### **COURT ABSOLVES PTC OF COMPETITION AUTHORITY FINE**

The Lisbon Appeal Court absolved PT Comunicações (PTC) last 22 December from paying a 38 million euro fine applied by the Competition Authority for allegedly denying without due cause access by TV Tel and Cabovisão to certain sections of its conduits. The Appeal Court's ruling confirmed the sentence handed down by the Commercial Court on 2 March 2010 and cannot be appealed, PTC indicated in a statement sent to the Portuguese Securities Market Commission (CMVM).

### **OPTIMUS AND VODAFONE PARTNERS IN NGNs**

The operators Optimus and Vodafone signed last 17 December an agreement to share next generation network (NGN) infrastructures in Lisbon and Porto. The companies explained in a statement that this partnership will allow commercial offers to be made available under this new framework in the first quarter of 2011. The two operators consider that this agreement whereby the networks remain the property of each respective

company will generate synergies and is a simple solution for consolidating the previously announced partnership. Optimus and Vodafone also admit the possibility of opening the NGN sharing agreement to other interested operators.

### **ELECTRONIC COMMERCE**

#### **- 3<sup>RD</sup> QUARTER 2010 BAROMETER**

The third quarter 2010 edition of the Barometer of Electronic Commerce in Portugal has been published, an initiative of the Association for Electronic Commerce and Interactive Advertising (ACEPI) and the Netsonda company, which reveals that more than half (65 percent) of the websites surveyed indicated that the number of customers making purchases on their sites grew by up to 20 percent. The study also indicates that 47 percent of the respondents say sales volume grew from 0 to 10 percent compared to the same quarter in 2009, versus the 19 percent of websites indicating a drop-off in sales. The Barometer also reveals that during the analysis period 41 percent of those surveyed upped investment in their websites, while 49 percent kept the same level.

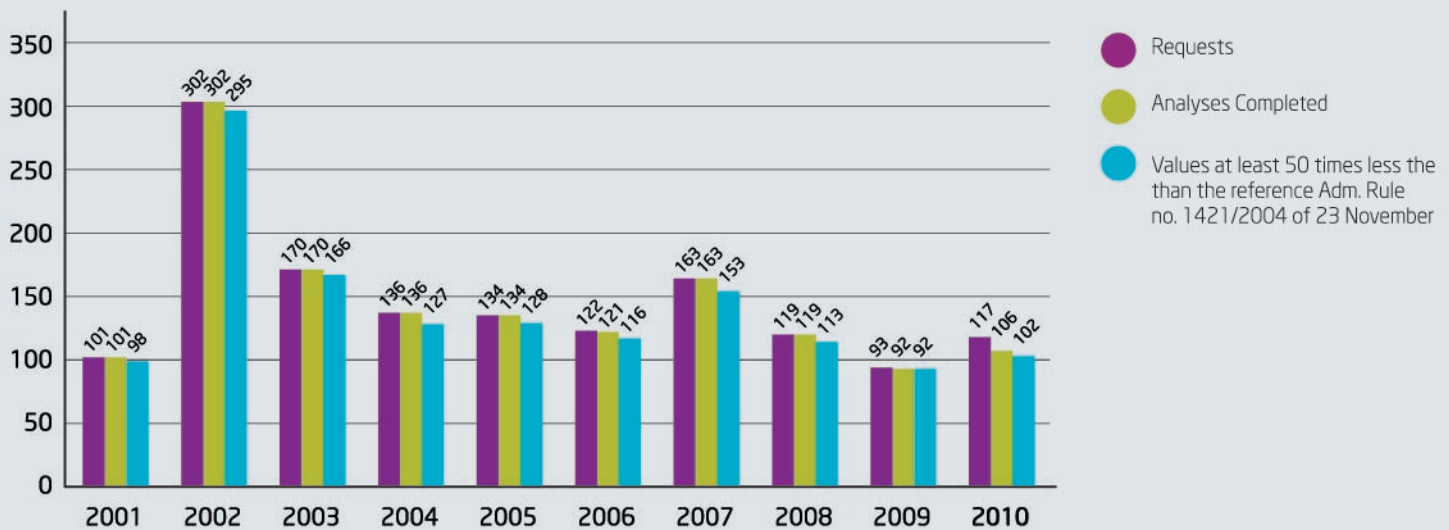
### **RADIO VODAFONE ON THE AIR IN 2011**

Vodafone FM is the name of a new radio station in Portugal which the mobile phone operator plans to launch early this year, devoted entirely to music and targeting an urban and young audience. The initiative results from a project presented by Media Capital Rádios.

### **2010 PLUG PRIZE - WINNER**

The work on "Cognitive Radios" by Nuno Borges de Carvalho, José Vieira, Arnaldo Oliveria, Pedro Cruz, Daniel Albuquerque and Nelson Silva of the Department of Electronics, Telecommunications and Computers of the University of Aveiro has won the 2010 PLUG Prize, awarded in the contest promoted by the Association of Telecommunications Operators (Aritel). Three projects also received honourable mentions: "Next Generation Access Networks - the post-investment conundrum" by Ricardo Gonçalves and Álvaro Nascimento; "Is the Continuity Approach Always the Best Policy to Regulate Next Generation Networks?" by Duarte Brito, João Vareda and José Pereira; and "Co-Investment in NGAs and Competitive Assessment of Horizontal Co-operation Agreements" by Gonçalo Borges.

## ROAMING QUESTIONNAIRE - RESPONSES BY 31 JANUARY

The Body of European Regulators of Electronic Communications (BEREC) has published the seventh data specification form on roaming in public mobile telephone networks in the European Union (EU), which should be filled out and returned to the *Autoridade Nacional de Comunicações* (ANACOM) by

31 January, to the email address [dee.stats@anacom.pt](mailto:dee.stats@anacom.pt). This data collection form covers the period from 1 July to 31 December 2010; the information gathered will be included in a report to be produced by BEREC and which should be published in late March 2011. (+)

## EUROPEAN UNION

### NUMBERING - EC CONSULTATION

The European Commission has launched a public consultation in the scope of Digital Agenda development, on the creation of single Europe-wide telephone numbers for European Union (EU) enterprises. By means of this consultation, whose deadline is 28 February, the EC aims to evaluate existing market demand for such single telephone numbers and if necessary prepare initiatives for their introduction. (+)

### UNIVERSAL SERVICE - BEREC CONSULTATION

The body of European Regulators for Electronic Communications (BEREC) placed in public consultation until 13 January the draft report on cross-border questions under terms of article 28 of the Universal Service Directive - Directive 2002/22/EC, revised by Directive 2009/136/EC. (+)

### ROAMING - BEREC REPORT AND CONSULTATION

BEREC published last 8 December 2010 the "Report on International Mobile Roaming Regulation". BEREC's analysis suggests the existence of structure problems at wholesale and retail levels which hinder competition. This report contains BEREC's opinion on the functioning and possible extension of

the European roaming regulation (EC Regulation no. 717/2007 of 27 June, modified by EC Regulation no. 544/2009 of 18 June), which charges the European Commission with undertaking its revision and, after public consultation, submitting the corresponding report to the European Parliament and to the European Council by 30 June 2011. To that end, the EC should consider the independent analysis done by BEREC. (+)

The EC has meanwhile launched a consultation on the revision of EU rules concerning mobile phone use abroad (roaming), which is open to comments until 11 February. The results obtained will serve as basis for the above-mentioned revision of the current European roaming regulation. (+)

### eGOVERNMENT - ACTIONS PRESENTED BY THE EC

The European Commission adopted last 16 December 2010 a Communication on strategy "For the Interoperability of European Public Services". The EC had the previous day disclosed another initiative for the sector, publishing the European action plan for online public administration (e-government). The EC Communication aims to establish a common approach for member-state governments and thus help citizens and companies fully benefit from the European Union's single market.

# COMMUNICATIONS AROUND THE WORLD

The document encompasses the European Interoperability Strategy and the European Interoperability Framework. For its part, the eGovernment action plan envisages the adoption of 40 specific measures in the next five years, divided into four categories. (+)

## **POSTAL SECTOR - EC STUDIES PUBLISHED**

The final reports from the postal sector studies promoted by the European Commission are now available: "Main Developments in the Postal Sector, 2008-2010", by Copenhagen Economics, and "Study on the External Dimension of the EU Postal Acquis", by WIK-Consult and Jim Campbell. (+)

## **INTERNET ACCESS AND USE - EUROSTAT DATA**

The number of homes with broadband connections has doubled since 2006, rising from 30 percent to 61 percent at the end of the first quarter of 2010 (1Q10), indicate figures released by the Statistical Office of the European Union (Eurostat). The published information ("Internet Usage in 2010 - households and individuals") also indicates that in Portugal the number of homes with internet access rose from 35 percent in 2006 to 54 percent in 2010; those with broadband connection doubled, from 24 percent (2006) to 50 percent (2010). Eurostat also reveals that, per household type, internet access existed in 80 percent of homes with children, a figure which dropped to 44 percent in those with no children. (+)

## **SECURE ONLINE PURCHASES - ENISA STUDY**

The European Network and Information Security Agency (ENISA) recently published a white paper on "How to Shop Safely Online", a study on how to make secure online purchases, to which ANACOM also contributed. (+)

## **NEELIE KROES - SPEECHES IN DECEMBER 2010**

The speeches given in December by the European Commission's Vice-President and Commissioner for the Digital Agenda, Neelie Kroes, have been posted online and concern the following topics: "Network and Information Security" (Tech-America event on joint EU/US cybersecurity, Washington, 16/12/2010), "My Vision for eGovernment, and How to Make it Real" (Lift-Off towards Open Government Conference, Brussels, 15/12/2010), "Towards a Single Market for Mobile Roam-

ing" (GSMA Europe's Mobile Day - Annual Reception, Brussels, 08/12/2010), "Unlocking the Digital Future through Open Innovation" (4<sup>th</sup> Pan-European Summit on Intellectual Property, Brussels, 03/12/2010) and "The Challenge of Open Access" (Launch of the OpenAIRE initiative, Ghent, 02/12/2010). (+)

## **HUNGARY ASSUMES EU PRESIDENCY**

Hungary holds the Presidency of the Council of the European Union (EU) for a six-month term beginning on 1 January. It will be followed in the second half of 2011 by Poland. In sector-related terms, Hungary's aim is to continue implementation of the European Digital Agenda (part of the 2020 Europe Strategy) and in June 2011 will organise the Digital Assembly for the first time, an event where the action plan will be debated by all interested parties. The Hungarian presidency will also endeavour to successfully conclude the negotiations on modernising the European Network and Information Security Agency (ENISA). A ministerial conference has also been scheduled for April 2011, covering issues associated to the protection of critical information infrastructures. Spectrum policy is also a priority area for the new presidency. It thus expects to continue talks concerning the First European Radio Spectrum Programme and will try to achieve a political agreement. Hungary also aims to begin preparatory work for the 2012 World Radiocommunication Conference (WRC-12) of the International Telecommunication Union (ITU), to present European common interests. (+)

## **COMMON CHARGER - EC DISCLOSES STANDARDS**

The European Commission has announced that the European standardisation bodies (the European Standardisation Committee (CEN), the European Committee for Electro-technical Standardisation (CENELEC) and the European Telecommunications Standards Institute (ETSI)) have released harmonised standards for the creation of a common mobile phone charger compatible with all models that support data connections. This announcement follows the agreement reached in June 2009, when 14 global mobile phone makers endorsed a project to harmonise chargers of mobile phones with data connections in the European Union (EU). The EC estimates that the first mobile phones and respective chargers compatible with the new standards should be market available in 2011. (+)

## EC RELEASES STUDY ON ONLINE PARENTAL CONTROL

In the scope of the "Safer Internet" programme, the European Commission has released results of a study comparatively evaluating parental control tools for protecting children online. Titled "Benchmarking of Parental Control Tools for the Online Protection of Children", the study indicates that existing software is good for filtering online content meant for adults,

although there is at least a 20 percent chance that websites with material not suitable for children are not blocked. The EC will continue conducting such analyses until the end of 2012. Another survey, "EUKidsOnline" meanwhile reveals that about a quarter of parents block or filter websites (28 percent) and/or track the websites viewed by their children (24 percent). (+)

## WG NaN CONSULTATIONS - RESPONSE UNTIL MARCH 2011

The CEPT ECC working group on Numbering and Networks (WG NaN) has placed the following documents in consultation: "Calling Line Identification and Originating Identification",

with responses accepted until 31 March, and "Numbering and Addressing for Machine-To-Machine (M2M) Communications", with an 18 March response deadline. (+)

# NEWS FROM OTHER COUNTRIES

## **AUSTRALIA – Australian Communications and Media Authority (ACMA)**

- Performance of the fixed telecommunications service providers improved in the 2009-2010 period, indicates the "Telecommunications Performance Bulletin 2009-10" published by the regulator. (+)

## **BELGIUM – Institut Belge des Services Postaux et des Télécommunications (IBPT)**

- The regulator has launched a tender for a study and the implementation of measures concerning the impact of LTE/WiMAX signals on radars operating in the 2700-2900 MHz band. The bids will be opened on 15 February.

## **BRAZIL – Agência Nacional de Telecomunicações (ANATEL)**

- The regulator and the fixed telephony concession companies – Brasil Telecom, CTBC Telecom, Embratel, Telemar Norte Leste (Oi), Sercomtel and Telesp (Telefónica) – have signed the extension of concession contracts until May 2011.
- The number of Brazilian households with access to subscription television stood at 9.53 million at the end of November 2010, for 27.5 percent accumulated growth since the beginning of the year. Taking into account the average number of 3.3 people per household indicated by the Brazilian Geography and Statistics Institute (IBGE), subscription TV services therefore reach about 31.4 million Brazilians.
- The regulator has placed in public consultation until 21 March the proposed revision of the fixed telephone service regulations.

## **CANADA – Canadian Radio-television and Telecommunications Commission (CRTC)**

- The regulator announced that its new rules of practice and procedure, henceforth to be simultaneously applied to the broadcasting and telecommunications sectors, take effect on 1 April. (+)

## **SPAIN – Comisión del Mercado de las Telecomunicaciones (CMT)**

- Mobile telephone service accounted for nearly 54 million subscriptions at the end of November 2010. During the same period broadband accounted for 10.5 million connections, for 8.5 percent growth over the previous year.
- The regulator published the half-yearly report comparing broadband prices in the 27 European Union member states. The document indicates that broadband and voice packages at middle speed (from 2Mbps to 10 Mbps) are 21 percent more expensive in Spain versus the best European offers, in prices adjusted to buying power parity.

## **USA – Federal Communications Commission (FCC)**

- The regulator adopted an order meant to preserve the free and open internet, based on three principles: transparency, no blocking and no unreasonable discrimination. (+)

## **FRANCE – Autorité de Régulation des Communications Électroniques et des Postes (ARCEP)**

- The regulator has published a study evaluating the needs of people who are deaf or hearing impaired (in France there are about 5 million people with hearing disabilities, or 8 percent of the population) with respect to access to telephone services. (+)
- Definitive third quarter 2010 results from the communications market observatory have been disclosed.

## **IRELAND – Commission for Communications Regulation (ComReg)**

- A document considering various questions associated to inclusion of the 1800 MHz band in the proposed award of spectrum which covers the 800 MHz and 900 MHz bands has been placed in public consultation until 28 January. (+)
- The regulator has published a set of guidelines for submitting competition complaints concerning the electronic communications sector. (+)

## **UNITED KINGDOM – Office of Communications (Ofcom)**

- Per the government's guidelines, the regulator decided to modify spectrum usage licences in the 900 MHz and 1800 MHz bands (used by second generation telephony) so that operators can also transmit third generation mobile telephony (UMTS). (+)
- The regulator launched four public consultations on the way it conducts its internal processes; the response deadline is 11 February. The topics considered are:
  - Guidelines for handling regulatory disputes; (+)
  - Review of procedures for handling broadcasting complaints, investigations and sanctions; (+)
  - Procedures for handling appeals on scope and for imposing sanctions in relation to on-demand programme services; (+)
  - Revising the penalty guidelines. (+)

## **SWITZERLAND – Federal Office of Communications (OFCOM)**

- The regulator announced that bills for television and radio reception fees will from 1 January on no longer be sent quarterly but rather once per year. This (annual payment) measure should save an estimated 9 to 10 million Swiss francs (about 8 million euros). (+)

## ANACOM PUBLIC TENDER – AUDIT OF CTT ACCOUNTING

By determination dated 30 December 2010 ANACOM approved the launch of a public tender to audit results from the cost accounting system of the Portuguese postal service provider CTT-Correios de Portugal, S.A. (financial years 2009 to 2011). The respective notice was published in series 2 of the official

gazette on 4 January. Interested parties are asked to submit their bids by 4 p.m. on 21 February via the electronic platform [www.compraspublicas.com](http://www.compraspublicas.com). The list of bidders will be posted on that electronic platform the day immediately after the bid submission deadline. (+)

## FIXED COMMUNICATIONS AND NOMAD VoIP – NEW STATISTICAL QUESTIONNAIRE

ANACOM approved last 30 December 2010 the draft decision concerning revision of the quarterly statistical questionnaire on electronic communications at a fixed location and nomad VoIP. This new questionnaire is meant to replace and integrate indicators previously included in the questionnaires on fixed telephone service, nomad VoIP and internet access service (at

a fixed location) and in the questionnaire on fixed interconnection and retail services for the purpose of determining relevant markets and assessing SMP. This draft decision was submitted to the prior hearing of interested parties for a period of 25 working days, in accordance with the Code of Administrative Procedure. (+)
