REGULATION OF SPACE ACTIVITIES

As the designated space authority, the Autoridade Nacional de Comunicações (ANACOM) approved last 18 July the regulation for the system governing the access to and practice of spacerelated activities. The aim is to ensure that appropriate resources are available and to streamline procedures. (+)

GUARANTEED OPEN INTERNET ACCESS

ANACOM approved by decision dated 26 June the report on net neutrality with respect to application of articles 3 and 4 of Regulation (EU) 2015/2120 of the European Parliament and of the Council of 25 November 2015. It covers the monitoring and supervisory actions carried out by this Authority during the period from 1 May 2018 to 30 April 2019. (+)

CTT COST ACCOUNTING SYSTEM

ANACOM approved on 18 June the final decision regarding actions deriving from the audit of results of the cost accounting

system of CTT-Correios de Portugal (Portuguese postal service) for financial year 2016. **(+)**

CTT - COMPLAINT BOOK

By decision dated 25 July, ANACOM approved a determination to correct the information disseminated by CTT regarding obligations envisaged in the system governing the complaint book, specifically the existence and availability of the complaint book at post offices. (+)

COMMUNICATIONS AROUND THE WORLD

UNIÃO EUROPEIA

FINLAND ASSUMES EU PRESIDENCY

Finland holds from 1 July to 31 December the rotating sixmonth presidency of the Council of the European Union (EU), continuing the presidential trio that also comprises Romania (first half of 2019) and Croatia (first half of 2020).

The Finnish presidency's main priorities for the next six months are to: i) strengthen common values and the rule of law; ii) make the EU more competitive and socially inclusive; iii) reinforce the EU's position as a world leader in climate-related action; and iv) boost protection of citizens' security. (+)

CONNECTING EUROPE FACILITY - DIGITAL

The public consultation launched by the European Commission (EC) to gather opinions from European citizens, industry, academic institutions and the public sector regarding the Connecting Europe Facility - Digital for the 2021-2027 period runs until 6 September.

In the scope of this financing programme, the EC issued a call for the areas of cyber-security, e-health, e-procurement, European e-justice, the European Platform for Digital Skills and Jobs and public open data. Interested parties can apply until 14 November. (+)

WIFI4EU - VALIDITY EXTENDED

In the scope of the second call under the EC's WiFi4EU

initiative, the validity of the reserve list of municipalities has been extended until 5 September. The list will only be activated if municipalities selected to receive a WiFi4EU voucher do not sign the subsidy agreement in the WiFi4EU portal. (+)

EUROPEAN BROADBAND AWARDS 2019

The deadline for applying to compete for the 2019 European Broadband Awards, an annual EC event distinguishing projects in the area of broadband implementation in the EU, has been extended until 6 September at 3 p.m. (mainland Portugal time). These prizes are awarded to projects in an advanced state of implementation, regardless of size, location or technologies used. The contest is addressed to local, regional and national public authorities as well as to projects with private financing. (+)

5G - COMMISSION APPROVES DECISION

The EC has adopted Implementing Decision (EU) 2019/784 on harmonisation of the 24.25-27.5 GHz (or 26 GHz) frequency band for terrestrial systems able to supply wireless broadband electronic communication services in the European Union, an important step towards implementation of 5G throughout Europe. 7TH BEREC STAKEHOLDERS FORUM

The seventh Stakeholders Forum of the Body of European Regulators for Electronic Communications (BEREC) was held last 16 October in Brussels. The aim was to boost dialogue, involvement and cooperation between BEREC and bodies interested in its activity. (+)

COMMON POSITION - INFRASTRUCTURE SHARING

The 39th BEREC plenary meeting was held last 12-14 June in Ghent, Belgium. One highlight was approval of the common

position on infrastructure sharing, which identifies criteria that may be considered by national regulatory authorities when assessing agreements to share mobile infrastructures under their responsibility. (+)

OECD RELEASES BROADBAND STATISTICS

The Organisation for Economic Cooperation and Development (OECD) recently released broadband figures referring to 2018. Portugal notably has a fixed broadband

penetration rate of 36.8 percent and ranks ninth from the top among the OECD countries with respect to fibre-optic penetration. (+)

2019 DIGITAL INDEX

The EC published last 11 June the report on the Digital Economy and Society Index (DESI) for 2019, which monitors the overall digital performance of Europe and the EU countries' progress in digital competitiveness. Portugal ranks 19th overall among the 28 EU member-

states. Specifically regarding the aspect of 'connectivity', the report analyses the development of fixed and mobile broadband infrastructure and its quality; in this aspect Portugal ranks 18th. Compared to the previous DESI, the country scored slightly higher. (+)

ARGENTINA - Ente Nacional de Comunicaciones (ENACOM)

• An extension of the agreement between ENACOM and the National Women's Institute (INAM) has been signed, envisaging the delivery of tablets to women who live in rural areas. The aim is to help their social development, integration and placement through the use of information and communication technologies (ICTs), thereby reducing the social divide. (+)

AUSTRALIA - Australian Communications and Media Authority (ACMA)

• The first report on complaints by Australian consumers regarding companies that provide telecommunication services was released on 10 July, focusing on the period from July to December 2018. The report's figures indicate that 108 complaints were presented per 10,000 services (up 10.2 percent over the previous quarter), with an average response time of six days. (+)

BELGIUM - Belgian Institute for Postal services and Telecommunications (BIPT)

- The deadline for responding to the public consultation on monthly tariffs for wholesale access to cabled networks is 6 September. (+)
- The deadline for responding to the public consultation on the reference offer of the telecom operator Proximus for bitstream access to the local fibre loop is 16 August. (+)

BRAZIL - Agência Nacional de Telecomunicações (ANATEL)

- The revised fixed telephony rates for the local and national long-distance (interurban) modes was approved on 11 July. (+)
- The infrastructure-sharing manual was approved on 11 July. It envisages that the company holding infrastructure must make available, via electronic systems indicated by ANATEL in the operational manual and within 180 days, geo-referenced technical information on infrastructures available for sharing, including all criteria used for price-setting and periods/deadlines. (+)

CANADA - Canadian Radio-television and Telecommunications Commission (CRTC)

• The statistical report on communication technologies in Canadian households during the 2013-2017 period has been published. It presents an overview of communication technology use by Canadian families and of consumption trends. (+)

UNITED STATES OF AMERICA - Federal Communications Commission (FCC)

• The report on the state of communications in areas affected by tropical storm Barry has been released. It includes information on communication network disruptions reported by service providers to the FCC's Disaster Information Reporting System. (+)

SPAIN - Comisión Nacional de los Mercados y la Competencia (CNMC)

• Telecom sector statistical information for year 2018 has been released, indicating that mobile broadband is driving growth. Fixed broadband lines with a speed equal to or above 100 Mbps account for 60 percent of all contracted lines. (+)

FINLAND - Finnish Transport and Communications Agency (TRAFICOM)

• Statistical figures have been released on the business volume of telecommunications in 2018, which remains at the level recorded in 2017. There was a 3 percent increase in mobile networks and a 4 percent decline in fixed networks. TV and radio services were 6 percent lower. (+)

FRANCE - Autorité de Régulation des Communications Électroniques et des Postes (ARCEP)

 A public consultation on high and very-high speed fixed access began on 11 July. The aim is to make an overall assessment of the current market analysis cycle and survey prospects for the next cycle. The consultation runs until 27 September. (+)

GREECE - Hellenic Telecommunications & Post Commission (EETT)

• A public tender for the contracting of consultancy services for development of the project for procurement of a satellite communications spectrum monitoring system has been launched. The deadline for submitting proposals is 13 September. (+)

The NETHERLANDS - Authority for Consumers and Markets (ACM)

• The third annual net neutrality report has been published, covering the period from 1 May 2018 to 30 April 2019. It provides information about the implementation of Regulation 2015/2120 of the European Parliament and of the Council, and the main priorities for next year. (+)

MONACO - Gouvernement Princier - Principality of Monaco

• Total coverage of Monegasque territory with 5G technology was announced on 9 July. The introduction of this technology is the first pillar of the Extended Monaco programme, which aims to lead Monaco to the digital era. (+)

UNITED KINGDOM - Office of Communications (Ofcom)

• New user-protection measures have been implemented for portability processes involving fixed telephone numbers. According to the new rules, operators must resolve complaints by users within five days. (+)

de Portugal (Portuguese postal service) applicable to financial year 2019: 10.2879 percent. (+)

By decision dated 26 June, ANACOM approved the evaluation of cross-border unit rates practiced by CTT in 2019 as universal postal service provider, pursuant to article 6 of

Regulation (EU) 2018/644 on cross-border parcel delivery services and respective communication to the European Commission (EC). (+)

DEDUCTION FROM CTT RECORDS

By decision dated 18 July, ANACOM approved CTT's request to make deductions from mailing records for the purpose of calculating values of the quality-of-service indicators. (+)
By order dated 3 July, it rejected CTT's request to make

deductions from the records of mailed priority mail and registered mail for the purpose of calculating values of quality-of-service indicators in 2019. (+)

OUALITY-OF-SERVICE INDICATOR VALUES IN 2018

By decision dated 11 July, ANACOM determined a reduction of postal service prices due to CTT's noncompliance with quality-

of-service indicators in 2018. (+)

LOWER FIBROGLOBAL PRICES

Fibroglobal has changed the prices for its wholesale offerings of high-speed networks in the Central and Azores zones of Portugal, in line with what was proposed by ANACOM and determined by the Portuguese state. Prices have been reduced by between 30 percent and 66 percent on average, depending on the access types. (+)

ANACOM launched the My Favourite Stamp contest, open to the public until 31 October, at the head office of the Azores Region

Association of Engineers in Ponta Delgada. (+)
